Our proposed plan was developed based on previously identified school needs through our annual LCAP process. District leadership facilitated meetings with parents, including parents of students with disabilities and parents of English learners, our local bargaining unit, community members, Board members, teachers, and staff, where conversations were held about what each group felt was going well in the District and where additional work needed to be done. Our SELPA was also consulted to ensure that needs were being addressed. Parents of unduplicated students were given the opportunity to address concerns and offer input. The administrative team identified priorities that were not able to be funded from other funding sources in the current school year. The plan will be submitted to the Governing Board in October for review, discussion, and approval.

A description of how the development of the plan was influenced by community input.

The basis of our plan was built upon the knowledge gained through our annual LCAP process of identifying school and student needs and receiving stakeholder feedback on the development of ensuing goals and actions. The biggest needs identified by stakeholder groups were to implement response to intervention and support social and emotional needs. The category "Addressing the Impact of Instructional Time" allows us to devote the ESSER III funding to provide an additional teacher and instructional aide, which allows for more Tier 1 and Tier 2 interventions within the classroom setting. The teacher and the aide will work with targeted groups in the classrooms, especially during

centers. Additionally, a garden teacher pulls groups from the classroom weekly, providing a chance for increased engagement of students and reducing teacher to student ratio. For instance, when half the class is at garden, the other half of the students are in small groups with the classroom teacher and intervention teacher. In some cases, this may allow for 2-3 students per group.

# ESSER III Expenditure Plan Instructions

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

  - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

  - Implementing evidence-based activities to meet the comprehensive needs of students,
  - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
  - Tracking student attendance and improving student engagement in distance education;

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
